LOOKING BACK ON 2005

A Year of Triumph Touched With Sadness

Last year ran the gamut of emotions, from professional and political highs to a great professional and personal loss. On balance, 2005 saw very significant gains for IBEW Local 18 members and families—for our collective family.

First and foremost, we secured a strong and fair contract, one that reflects the outstanding work we do, as well as the respect we deserve. Then, when we had to, we flexed our political muscle and helped spearhead two major campaigns. Bottom line: Local 18 continued to be a force in the city, a "player" that continued to achieve everything it could on *your* behalf.

In all, four very significant events highlighted 2005, and in looking back on them in chronological order, we have to begin with the most heart-wrenching of them.

THE PASSING OF BROTHER MIGUEL CONTRERAS

On May 6, we were stunned to learn of the untimely and completely unexpected death of Miguel Contreras, the very personable and effective leader of the Los Angeles County Federation of Labor. It just did not seem fair: a heart attack at the relatively young age of 52! Even as we struggled to understand why this happened, we remembered Brother Contreras' life and work.

His successes were enhanced, for me, by an enjoyable and enduring personal friendship, both on the job and away from the office. *I continue to miss you, my friend,* even as we welcome the leadership, oratory and political skills of the Fed's new and able leader, Brother Martin Ludlow.

Martin was the Fed's skilled and successful political

director before serving on the Los Angeles City Council. Following Miguel's passing, he quickly became the obvious and strong candidate to succeed as Secretary-Treasurer. Both in recent municipal elections, and as a key player in the statewide campaign against the governor's lousy ballot initiatives, Brother Ludlow proved to be a very shrewd and resourceful political strategist and leader. He is turning out to be a worthy successor to Miguel Contreras, and we look forward to working closely and productively with him and the Fed on issues of mutual interest and import.

THE ELECTION OF MAYOR ANTONIO VILLARAIGOSA

On May 17, we helped elect *one of our own*, a former union organizer and president, as Mayor of the City of Los Angeles. Brother Antonio Villaraigosa, one-time Speaker of the State Assembly and City Councilman, came out of the union movement. He instinctively grasped the concerns and goals of working men, women and families. He appreciated unions, and had been a good friend to Local 18.

His priorities reflect the goals of organized labor and the people and families it represents. His heart—and his vision—are in the right place. We continue to want to work with him on issues of mutual interest and import, both concerning the Department of Water and Power, and the general welfare of our city and its residents.

WINNING A NEW CONTRACT

On September 20, by a 10-3 margin, the Los Angeles City Council formally approved our new five-year contract with the Department of Water and Power.

Our negotiating team, backed by the determination and righteous cause of our members, secured an excellent deal, a triumph of patience, bargaining skills and, when needed, some good old-fashioned public solidarity and political muscle. "Will Strike if Provoked" and "A Deal is A Deal" became our rallying cries, and they echoed throughout the Department, across the city and at City Hall.

Our contract provides job security, fair wages, continuing excellent benefits, and more secure and brighter futures for Local 18 members and families. It is the essence of union activity and the very reason for the existence of Local 18. It represents a deal fairly and openly reached between labor and management, and it reinforces the value of our work: since, for some years, utility rates for DWP customers have been some 25% below those of other regional providers, clearly you—our hard-working members—must be doing something right. And you are—every day!

DEFEATING THE GOVERNOR'S "REFORMS"

On November 8, working Californians, spearheaded by organized labor, led an overwhelming rejection of the governor's ill-conceived, vindictive, out-of-themainstream and *unnecessary* slate of so-called "reforms." Reforms they were *not*; they were regressive and targeted against the working men and women who serve California every day.

Organized labor, assisted greatly by the statewide IBEW, helped defeat all this nonsense. We "terminated the terminator!"

The year 2005 saw great triumphs, tempered by loss. It saw the IBEW Local 18 family make significant professional and political gains. It was, on balance, a good year. Now, we look forward to building on our success *this year*.

PRE-DESIGNATE PERSONAL PHYSICIAN IN THE EVENT OF WORK INJURY – at DWP Workers' Compensation Office. California law requires your employer to provide and pay for medical treatment if you are injured at work. If you choose your own physician or chiropractor prior to a work related injury, you have the right to treat with that personal physician or chiropractor. Forms may be obtained at the DWP Workers' Comp office.

EDUCATIONAL ASSISTANCE – Local 18 will finance tuition fees and 50% of the cost of required books for union labor-oriented classes *for members only.*

SCHOLARSHIP FUND – Local 18 offers two Trade School Grants per year to union members enrolling in technical, industrial or trade schools — \$250.00 yearly for two years (a total of \$500 per student). In addition, the International Union offers a maximum of 12 scholarships yearly to *members only* for undergraduate study. The scholarships are each worth up to \$3,000 per year to a maximum of eight years.

<u>INQUIRE ABOUT PRESCRIPTION SAFETY GLASSES</u> — Eligible employees are those who require the use of medically prescribed glasses to perform their primary work tasks, and whose primary work requires the use of safety eye wear by Department policy and/or CalOSHA regulations. Work Stress: *Keeping Your Heart Healthy*



Usually, I discuss heart-related matters in February, which is Heart Health Month. But two recent research articles grabbed my attention. I believe they serve as a "wake-up" call for IBEW Local 18 members who not only must deal with non-stop "on-the-job" stress

issues out in the field, but also those who have to cope with a bureaucracy and perhaps a difficult boss. *This can be an intense source of stress.* And while stress has yet to be *directly* associated with heart disease, the links are becoming apparent.

One study, which appeared in *The Archives of Internal Medicine*, linked "fair bosses" to an employees' health status. Specifically, findings from the Finnish Institute of Occupational Health in Helsinki indicated that British civil servants who felt they were being treated fairly at work had a much *lower* incidence of coronary heart disease—the leading cause of death in all Western societies.

The researchers also found that employees who felt they were being treated fairly by their bosses took sick leave much less frequently than those who felt they were treated in an unfair manner. In this study, 6,442 male British civil servants ages 35 to 55 said they considered being treated fairly at work meant that their supervisor considered their viewpoint, shared information about decision-making, and treated individuals equally and in a truthful manner.

Interestingly, this research is in line with previous studies, one of which had shown that employees had lower blood pressure on days they worked with a supervisor they perceived as fair.

Another recent Finnish study published in *Psychosomatic Medicine* pointed to a possible connection between job strain in younger men and the beginnings of atherosclerosis, the build-up of plaque in the arteries that can eventually lead to a heart attack or stroke. Researchers found that among the more than 1,000 young adults they studied, men who reported high levels of job strain were more likely to show signs of early artery narrowing. The same, however, was *not* true of young women.

Indeed, according to the American Heart Association (AHA), more and more evidence suggests a

relationship between the risk of cardiovascular disease and environmental and psychological factors. These factors include job strain, social isolation and personality traits. If you combine work-related stress with other risk factors for heart disease, including smoking, high blood cholesterol, high blood pressure, physical inactivity, being overweight or obese, and diabetes, you really may be increasing your risk of heart disease.

The AHA said that more research is needed to find out how stress contributes to heart disease risk. But let's face it: managing stress makes sense for your overall health.

HAPPY HOLIDAYS?

And speaking of stress, the holiday season can also take it's toll on your health. A 1999 study in *Circulation*, the Journal of the American Heart Association, found that the highest number of deaths from coronary artery disease occurs in December and January. This is something to consider in the future.

Experts note that the stress of preparing for the holidays, combined with the tradition of overeating and over-drinking (not to mention working overtime on the holiday shift), increases a person's risk for heart disease.

Take it easy during the holidays, and don't let the pressures of the season—or your boss—stress you out! If you want to learn more about managing stress and/or lowering your heart disease risk, talk to your primary-care physician.





during the last few months, it is difficult to separate out all the highlights.

- ◆ You filled the City Council chambers and Unit Meetings whenever a special meeting was called. You stood together 100 percent when the time came to let the City of Burbank know exactly what you wanted; this is truly the highlight of these negotiations! - ◆ The Council approved a threeyear contract. It included the 2.5% @ 55 enhanced retirements, medical payments that will increase for many by \$300 per month, 100%-paid dental and vision coverage, a very good wage increase, an additional retiree medical subsidy, and more.
- ◆ Early retirement options are being offered to 10 of the most senior

- unit members, who would be least likely to take advantage of the enhanced-retirement benefit.
- ◆ I especially thank negotiatingteam members Bruce Redmann, Chris Besvold, Barry Heller, Elliott Azus, Sergio Carrasco, Jeff Hancock, Chuck Malys, Lonnie Maybin, and Russ Riegler. Your thoughts, ideas and leadership were invaluable.
- ◆ But in the end, it was every member, officer and representative's unity, courage and trust that won the day. Do not ever forget or lose site of these very vital and fundamental union ideals.
